



Submission Agreement of the Open Science Repository

The corresponding author and all the other authors warrant that the content of the submitted paper is original, created by the authors and that they have the right to submit it to the Open Science Repository for publication.

The corresponding author and all the other authors warrant that they have the right to submit the text, graphics, pictures and all other objects part of the paper. They also warrant that the content of the paper does not infringe copyrights owned by others.

The corresponding author and all the other authors agree that, once a notice of publication is sent to the corresponding author by email, the corresponding author has 3 business days to revise the paper and ask for correction of any detected problems in the edited paper. After 3 business days, the paper is considered approved by the authors. Requests for corrections or modification of the content of the published paper cannot be entertained after this time-period of 3 business days. They also agree that withdrawal of the paper from the repository is not permitted after publication.

The corresponding author and all the other authors understand that the Open Science Repository has the right to ban violators of its editorial policies from submitting again.

The corresponding author and all the other authors authorize the Open Science Repository to publish the paper under a Creative Commons Attribution 3.0 Unported (CC BY 3.0) license. The license means that authors retain ownership of the copyright but that the content can be used by others if the original authors and sources are cited.
